Notice is hereby given that on the 17<sup>th</sup> day of August 2017, the Board of Directors of READYMIX (WEST INDIES) LIMITED ("Readymix") granted approval for Readymix to enter into an agreement for the sale to East Lake Development Company Limited ("ELDC") of a parcel of land owned by Readymix and situate at Tumpuna Road, Guanapo, in the Ward of Arima comprising 18.9 hectares, being a portion of the lands owned by Readymix comprising approximately 213 acres. On the 18<sup>th</sup> day of August 2017, Readymix entered into the said agreement. The sale will facilitate the construction of a gated community of 10 multi-family buildings with a total of one hundred and eighty (180) residential condominiums and ninety-five (95) single family homes ("the Units") and complementary services, and the sale of the Units to third party purchasers together with roads, water, sewerage and drainage systems and other facilities and amenities, subject to the approval by the Town and Country Planning Division of the Ministry of Planning and Development and/or other competent planning authorities and all conditions, subject to which such development shall be permitted.

Via a shareholders agreement, Readymix will become a ten percent (10%) shareholder in ELDC.

It is intended that the raw materials for the construction of the Units and other facilities will be provided by the TCL Group.

By this project, Readymix, and by extension the TCL Group, is committed to bringing an affordable housing solution to the people of Trinidad and Tobago, and to contributing to the reactivation of our economy.
