The Trinidad and Tobago Stock Exchange Limited (TTSE) received notice from GKC that the Board announces the extension of the appointment of Professor the Honourable Gordon Shirley, O.J. as Board Chairman for an additional period of three years.

Professor Shirley will complete his first three years as Chairman of the GraceKennedy Board on December 31st, 2016. His new term as Chairman will commence on January 1st, 2017 and extends to December 31st, 2019.

Group CEO, Don Wehby, indicated that Professor Shirley has been a great Chairman providing insightful leadership to the Board and support for the Executive leadership. "We look forward to his continued guidance as we pursue our goal of becoming a Global Consumer Group."

Professor Shirley has a Doctorate in Business Administration and an MBA in Operations and Finance from Harvard University and a BSc in Mechanical Engineering from The University of the West Indies. He was conferred with one of the nation's highest honours, the Order of Jamaica, in 2009.
