GraceKennedy Limited (GKC) - 16.12.16

The Trinidad and Tobago Stock Exchange Limited (TTSE) received notice from GKC advising of the following organisational changes which will take effect on January 01st, 2017 and April 01st, 2017:

Grace Foods

Effective January 01st, 2017 the following changes will occur in the Grace Foods division:

- Gilroy Graham, who is currently Senior General Manager for Grace Foods & Services
 (GFS) within GK Foods Jamaica, will take up the role of Executive Chairman of
 GraceKennedy (Belize) Limited. He will report to Ryan Mack, CEO of Grace Foods
 International, in his new role. Andrea Coy, Chief Executive Officer, GraceKennedy
