Calypso Macro Index Fund (CALYP) - 22.09.17

The Trinidad and Tobago Stock Exchange Limited (TTSE) received notice from CALYP advising that the Ministry of Finance appointed Justice Rolston Nelson as Chairman of the Board of the Trinidad and Tobago Unit Trust Corporation for a period of two (2) years, with effect from September 14th, 2017.

GraceKennedy Limited (GKC) - 22.09.17
