Readymix (West Indies) Limited (RML) - 20.10.15

The Trinidad and Tobago Stock Exchange Limited (TTSE) received notice from RML that effective October 19th, 2015, Mr. Nigel Edwards was appointed Chairman of the Board of RML, in accordance with Section 12.1 of the Company's By-Law No. 1.

Readymix (West Indies) Limited (RML) - 20.10.15

The Trinidad and Tobago Stock Exchange Limited (TTSE) received notice from RML that Mr. Manan Deo, General Manager of the company, retired on October 16th, 2015 and that Mr. Andres Peña has been appointed as General Manager effective October 17th, 2015.

National Flour Mills Limited (NFM) - 19.10.15

The Trinidad and Tobago Stock Exchange Limited (TTSE) received notice from NFM of a special meeting of shareholders which will be held on Thursday 12th November, 2015 at NFM's Sports Club, Nos. 27-29 Wrightson Road, Port of Spain at 10:00 am for the purpose of considering and if thought fit, approving the following resolution as an ordinary resolution of the Company:

"That PricewaterhouseCoopers, Chartered Accountants be and are hereby appointed External Auditors of NFM to replace the incumbent Auditors – KPMG, to hold office until the conclusion of the next Annual Meeting of shareholders, and that the Board of Directors be authorized to fix their remuneration."

GraceKennedy Limited (GKC) - 16.10.15

The Trinidad and Tobago Stock Exchange Limited (TTSE) received notice from GKC of the sale of its shares in Hardware & Lumber (H&L). After an initial announcement by GraceKennedy in May 2015 regarding the planned divestment of its shares in subsidiary, H&L, and follow up announcement in June, that it had entered into a conditional agreement for the sale of the shares with Greystone Equity Partners Inc., ("Greystone") or nominee, GraceKennedy has advised that the main conditions of the transaction have now been met and the transaction will therefore be proceeding to closing. The sale is anticipated to be completed by the end of the year.

Group CEO, Don Wehby, stated that "As indicated at the GraceKennedy and H&L AGMs earlier this year, GraceKennedy's decision to sell our shares in H&L was not an easy one. It is however consistent with our present strategy of concentrating on the food business locally and internationally and financial services in the region".
