Guardian Media Limited (GML) - 27.05.16

The Trinidad and Tobago Stock Exchange Limited (TTSE) received notice from GML that Mr. Grenfell Kissoon retired as a Director and Chairman of the Board of Directors of the Company effective May 25th, 2016 and the appointment of its new Interim Chairperson – Ms. Teresa White also with effect from May 25th, 2016.

Trinidad Cement Limited (UCL) - 25.05.16

The Trinidad and Tobago Stock Exchange Limited (TTSE) received notice from TCL that Mr. Mario Emilio Sáenz Arroniz has tendered his resignation from the Board of Directors of the Company effective May 20th, 2016.

At a meeting of the Board of Directors held on May 20th, 2016, the Directors, in accordance with Paragraph 4.4.2 of the Company's By-Laws, appointed the Group Chief Executive Officer – Mr. Jose Luis Seijo Gonzales as a Director with immediate effect, to fill the vacancy caused by the resignation of Mr. Mario Emilio Sáenz Arroniz. The Board also agreed to appoint Mr. Seijo Gonzalez as Managing Director of the Company until April 30th, 2018, in accordance with Paragraph 6.11 of the Company's By-laws.

National Commercial Bank Jamaica Limited (NCBJ) - 20.06.16

The Trinidad and Tobago Stock Exchange Limited (TTSE) received notice from NCBJ of the following transactions:

- A Director purchased 1,667 NCBJ shares on May 18th 2016; and

These shares were purchased as part of the Dividend Reinvestment Programme (DRIP), under which shareholders set up standing instructions for dividends payable to them to be used to purchase more shares.

Guardian Holdings Limited (GHL) - 18.05.16

The Trinidad and Tobago Stock Exchange Limited (TTSE) received notice from GHL that Mrs. Marianne Loner resigned as a member of the Board of Directors of GHL with effect from May 13th, 2016. Mrs. Loner has chosen to resign her position given the recent changes in ownership of GHL, whereby the International Finance Corporation (on whose nomination as a shareholder her appointment to the Board was effected) no longer has an interest in the Company.

Guardian Holdings Limited (GHL) - 13.05.16

The Trinidad and Tobago Stock Exchange Limited (TTSE) received notice from GHL that further to their announcement in November 2015 and subsequent update on April 20th, 2016, GHL has been advised of the successful completion of the acquisition of a 29.99% stake in GHL by NCBJ with effect from May 12th, 2016. As indicated in our November 2015 announcement, the closing of this transaction included the sale by the International Financial Corporation (IFC) of its holding in GHL, so they no longer hold any shares in the company.

Although some shares have been sold by the Lok Jack and Ahamad families, they continue to have a significant stake in the company that now stands at 21.84%.
