<p>A.S. Bryden &amp; Sons Holdings Limited ("ASBH", "Company") announces the over-subscription and closure of its takeover bid to acquire shares in Caribbean Producers (Jamaica) Limited ("CPJ"). A total of 333 applications were received with an oversubscription of 25,045,445 shares.</p> <p>The Take-Over Bid was closed on February 14, 2025, with subscription details verified on February 17, 2025 and allotments confirmed on February 19, 2025. Pursuant to the terms of the Take-Over Bid Offer Circular, the Company will issue 14,695,025 ordinary shares of ASBH in settlement of the subscription on February 24, 2025 to the former CPJ shareholders who tendered their shares in the bid.</p>


