3. DESCRIPTION OF MATERIAL CHANGE

Description of Material Change
<p>Guardian Holdings Limited ("GHL") has been notified that by virtue of the acquisition of shares in GHL by companies directly and indirectly owned by Arthur Lok Jack, that he has become a substantial shareholder of GHL in accordance with section 182 of the Companies Act, Chapter 81:01. The details of the acquisition of GHL shares through Mr. Lok Jack's nominee's are as follows:</p> <ol style="list-style-type: none">1. Tenetic Limited, effective 12 May 2016, acquired the 100% shareholding in the company Lofty Trees Limited which, as its nominee, acquired 22,334,254 shares in the Company from RBC Royal Bank (Trinidad & Tobago) Limited, and 4,071,300 shares in the Company from RBC Financial Caribbean Limited, which is an aggregate amount of 26,405,554 shares. Tenetic Limited is owned by Associated Brands (Investments) Limited ("ABIL") and Universal Investments Limited in equal shares, and Arthur Lok Jack is the majority shareholder in ABIL, holding sixty-nine percent of the issued and outstanding shares in ABIL. By virtue of ABIL's 50% shareholding in Tenetic Limited, and as agreed between the shareholders of Tenetic Limited; namely, ABIL and Universal Investments Limited, an aggregate amount of 13,202,777 of said shares are attributable to Arthur Lok Jack's interest in the Company.2. ABIL, effective 12 May 2016:<ol style="list-style-type: none">a. , acquired the 100% shareholding in the company Crashing Waves Limited which, as its nominee, has acquired 2,879,881 shares in the Company from International Finance Corporation.b. , acquired the 100% shareholding in the company Shell Wave Limited which as its nominee, has acquired 959,961 shares in the Company from IFC ALAC GHL Holding Company Limited. <p>The aggregate shares acquired by ABIL, through these two nominees, are 3,839,842 shares.</p>

State the reasons for applying for the exemption
<p>By virtue of publications in the Press on May 13, 2016 Tenetic Limited advised of its acquisition of 26,405,554 GHJ shares. It was also disclosed in that notice that Tenetic was owned by ABIL and Universal Investments Limited and that on completion of the acquisition Tenetic and its affiliates would own 50,642,536 GHJ shares representing approximately 21,84% of the issued and outstanding shares of GHJ. This notice confirmed the intention notified to the press in the November 30, 2015 announcement of the pending NCBJ transaction that the Lok Jack and Ahamad families would continue to hold a very significant stake of approximately 22% of GHJ. Since the public have already been made aware of the significant stake held by the Lok Jack and Ahamad families in GHJ, we believe that publication of an Announcement advising of Arthur Lok Jack becoming a substantial shareholder in his own name under section 182 of the Companies Act Chapter 81:01 would not provide any more information to the investing public than they already have and could be confusing. We therefore request an exemption from this requirement.</p>
