<p>Please be notified that on 31st October 2024 (“Economic Transfer Date”) MPC Caribbean Clean Energy Limited has entered into the Sale Purchase Agreement (“SPA”) to sell its indirect share-holding in Paradise Park (“the Project) and by Q1 2025 the transaction is expected to be successfully completed (“Closing Date”).</p> <p>The majority shareholder issued a notice of intention to proceed with a third-party sale process in respect of their shareholding in the Project. Therefore, after receiving the final binding offer along with the notice related to tag along right, the Board of Directors of MPC Caribbean Clean Energy Limited approved to exercise its tag-along rights to participate in the sale.</p> <p>Please note, in June 2018, the Company acquired shareholding (indirect) in Paradise Park (the Project”), a 51 MWp solar park in Jamaica. The Project reached Commercial Operation Date in June 2019 and was the first acquisition of the Company.</p>



