**NOTICE OF HEARING**

**TAKE NOTICE** that the Trinidad and Tobago Securities and Exchange Commission ("the Commission") will convene a Hearing of the Matter pursuant to Section 159 (1) of the Securities Act, at the Commission, at 57-59 Dundonald Street, Port of Spain on **Monday, October 22nd, 2018, commencing at 10:00 a.m.**

**THIS HEARING IS BEING HELD TO CONSIDER** pursuant to sections 45 (1), (1A) of the Act and Rule 401 of the Trinidad and Tobago Stock Exchange Rules ("the TTSE Rules") whether it is in the public interest:

1. to conclude that Readymix (West Indies) Limited has met the de-listing criteria set out in Rule 401 of the TTSE Rules;
2. to grant the application of the Trinidad and Tobago Stock Exchange Limited, to de-list the ordinary shares of Readymix (West Indies) Limited; and
3. to make such further and other orders in relation to the Matter as the Commission considers appropriate.

**AS A PRELIMINARY ISSUE TO CONSIDER**

1. Whether the Hearing of the Matter should be held in private as requested by **Readymix (West Indies) Limited** Pursuant to section 159 (4) of the Act (“the Preliminary Issue”).

**AND TAKE NOTICE** that the Hearing Panel will hear submissions on the Preliminary Issue at **10:00 a.m. on Monday 22<sup>nd</sup> October 2018**. Upon the determination of the Preliminary issue, the application to de-list the ordinary shares of Readymix (West Indies) Limited from the Trinidad and Tobago Stock Exchange Limited’s “Official List” will be heard immediately thereafter.

**AND TAKE NOTICE** that any party to the proceeding may appear in person or be represented by Counsel at the Hearing. Affected parties who wish to be heard at the Hearing, are requested to make written submissions addressed to the Commission’s General Counsel/Corporate Secretary on: -

- the Preliminary Issue; and
- the Delisting Application
