**AND TAKE NOTICE** that the Hearing will be an expedited hearing pursuant to Rule 11 of the Hearings Rules and the first hearing in this matter shall be for the issuance of procedural directions and will be conducted at the Commission's Office located at 57-59 Dundonald Street, Port of Spain on **Monday February 26, 2018 at 1:30pm ("the Procedural Hearing")**.

Affected parties who wish to be heard at the Procedural Hearing, may appear in person or be represented by an Attorney-at-Law. Such parties are requested to make written submissions addressed to the Commission's General Counsel/Corporate Secretary by **3:00 p.m. on Friday February 23, 2018.**
