DESCRIPTION OF MATERIAL CHANGE

Description of material change

Republic Financial Holdings Limited ("RFHL") advises that pursuant to a resolution of its Board of Directors passed on 29th August, 2018 and having received all regulatory approvals, its Barbadian subsidiary, Republic Bank Trinidad and Tobago (Barbados) Limited ("RBTTBL"), has acquired 74.99% of the shareholding of Cayman National Corporation Limited ("CNC").

RBTTBL is a licensed offshore international financial business operating pursuant to the Laws of Barbados. As part of its structure, RBTTBL is the sole shareholder of Republic Bank (Cayman) Limited which is RFHL's subsidiary operating within the Cayman Islands.

The offer to acquire the shareholding in CNC resulted in the purchase of 31,755,842 issued shares in CNC at a price of US\$6.25 per share. The total cost of the transaction was US\$198,474,012.50.
