3. DESCRIPTION OF MATERIAL CHANGE

Description of material change

Further to Republic Financial Holdings Limited's ('RFHL') letter dated 3rd September, 2018, we advise that Republic Bank Trinidad & Tobago (Barbados) Limited ('RBTTBL'), a wholly owned subsidiary of RFHL, has made a proposal to the Board of Cayman National to acquire a minimum of 51% and up to 74.99% of the issued shares of Cayman National by way of a tender offer to Cayman National shareholders at US\$6.25 per Cayman National share.

In the said letter, we did advise that our next publication would occur when the implementation agreement is executed. However, we have been reliably informed that Cayman National will be publishing this information on the Cayman Stock Exchange's website on 12th September, 2018.

Given the forthcoming publication by Cayman National, we thought it prudent for RFHL to advise the Trinidad and Tobago Securities Exchange Commission of this development and to prepare a similar statement which will be made to the Trinidad & Tobago public via RFHL's website on 13th September, 2018 and in two (2) daily newspapers. The Notice is attached for ease of reference.

To note, the information recited here is contained in RFHL's letter dated 13th September, 2018 which was submitted to the SEC on the same date.
