Listed Company Information

Guardian Holdings Limited (GHL) - 18.02.2019

The Trinidad and Tobago Stock Exchange (TTSE) received notice from GHL advising that further to a Notice to Shareholders published on February 12th, 2019, they hereby advise that on February 14th, 2019 the Board of Directors was presented with a Notice of Extension of Closing Date issued by NCB Global Holdings Limited (NCBGHL or the Offeror) regarding its Offer and Take-Over Bid Circular dated the 31st day of December, 2018 (as amended by the Notice of Correction dated the 31st day of December, 2018; the Notice of Extension of Closing Date dated February 7th, 2019 and the Notice of Extension of Closing Date dated February 11th, 2019 the 'Offer Circular') to acquire up to Seventy-Four Million Two Hundred and Thirty Thousand Seven Hundred and Fifty (74,230,750) ordinary shares (the Offer Shares) so as to result in NCBGHL holding not more that 62% of the issued and outstanding shares in GHL at a cash price of US\$2.79 (the Offer).

GHL stated that except as otherwise set forth in their notice dated February 16th, 2019, there have been no changes to the terms and conditions of the Offer and, as such, those terms and conditions previously set forth in the Offer and Take-Over Bid Circular continue to be applicable in all respects. The Offer will accordingly remain open for acceptance until April 30th, 2019 at 4:00p.m. (the Extended Closing Date).

Trinidad Cement Limited (TCL) - 18.02.19

The TTSE received notice from TCL advising that Mr. Ruben Mc Sween, current member of the Board of Directors of TCL has given notice that he does not intend to offer himself for reelection at their next Annual Meeting. TCL further advised that Mr. Ruben Mc Sween will continue to serve as a Director until the conclusion of their Annual Meeting for the year ended December 31st, 2018.

Republic Financial Holdings Limited (RFHL) - 20.02.2019

The TTSE received notice from RFHL advising that together with Republic Bank Limited, they have arranged funding in the sum of approximately US\$217 million dollars from two (2) international banks for the purpose of partially funding the acquisition of up to 74.99% of the shareholding of Cayman National Corporation Limited.

JMMB Group Limited (JMMBGL) - 20.02.2019

The TTSE received notice from JMMBGL advising that a Director purchased 2,000 JMMBGL shares on February 15th, 2019 over the Jamaica Stock Exchange.

GraceKennedy Limited (GKC) - 20.02.19

The TTSE received notice from GKC advising that on Thursday, February 28th, 2019, the Board of Directors will consider a resolution for the declaration of an interim dividend to be paid in April 2019.

Trinidad Cement Limited (TCL) - 21.02.19

The TTSE received notice from TCL advising that a typographical error appeared in their Company's Summary Consolidated Audited Financial Report for the year ended December 31st, 2018, which was published in the print media on Wednesday, February 20th, 2019. The currency was misquoted as "J\$000", when in fact, the results are reported in Trinidad and Tobago dollars (TT\$000).
