First Citizens Bank Limited (FIRST) - 28.04.17

The Trinidad and Tobago Stock Exchange Limited (TTSE) received notification from FIRST advising of the details of the Offer for sale by First Citizens Holdings Limited of 48,495,665 ordinary shares of no par value at \$32.00 per share. The offer for sale has received 4,440 successful applications with subscriptions totalling \$1.025 billion.

Trinidad Cement Limited (TCL) - 24.04.17

The Trinidad and Tobago Stock Exchange Limited (TTSE) received notification from TCL advising that further to the publication made on January 26th, 2017, which provided shareholders with an interim update on the Offer and Take-Over Bid dated December 05th, 2016, issued by Sierra Trading (an indirect subsidiary of CEMEX, S.A.B. de C.V.) ("the Offer"), and following the close of the Offer, and final verification of the validity of all acceptances received by both the Trinidad and Tobago Central Depository and Republic Securities Limited, TCL hereby advises as follows:

- The total number of TCL shares acquired by Sierra Trading pursuant to the Offer was 113,629,723.
- The total consideration paid by Sierra Trading for the TCL shares acquired pursuant to the Offer was US\$86,358,589.50.
- Prior to the Offer, Sierra Trading owned 147,994,188 TCL shares, which represented approximately 39.5% of TCL's total issued and outstanding shares.
- As at April 19th, 2017, the aggregate number of shares owned by Sierra Trading subsequent to the Offer is 261,623,911 which represents approximately 69.83% of TCL's total issues and outstanding shares.

Bourse Brazil Latin Fund (BBLF) - 27.04.17
